Trucking Industry Faces Growing Administrative Challenges

Trucking businesses face complex safety and compliance requirements, stringent vehicle maintenance rules, and an influx of data from technology, leading to operational inefficiencies and profit losses.

A recent Fleetworthy survey of 300 industry professionals reveals that many fleet operators and independent truckers struggle to manage overwhelming paperwork, risking compliance and draining resources. Without efficient, automated solutions, these burdens threaten core business functions and worsen financial challenges.

AUDIT ANXIETY

Fleet operators seek technology solutions to solve inefficient records management

Fear of failing an audit is directly linked to documentation chaos. Only 35% of fleet operators believe their fleet would “definitely” pass a DOT audit – a discouraging sign for operational stability. The remaining 65% felt at least some level of doubt. Among respondents who weren’t sure if their fleets would pass a DOT inspection, the majority (87%) said compliance documentation issues were to blame.

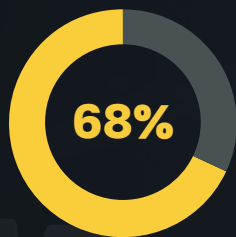

What will it take to reduce the paperwork burden?

Real-time alerts on compliance risks (68%) and compliance software with automation capabilities (65%) would have the most impact, according to roughly two-thirds of fleet operations decision-makers. Additionally, more than half (53%) would welcome help from a consultant to streamline compliance processes.

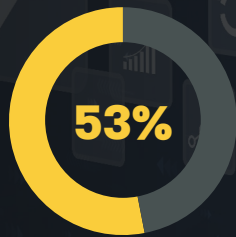

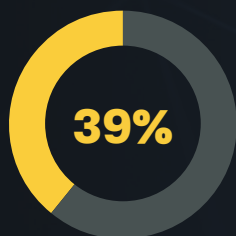

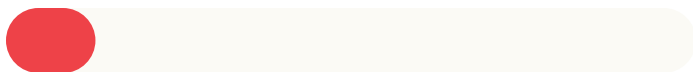

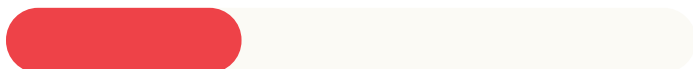

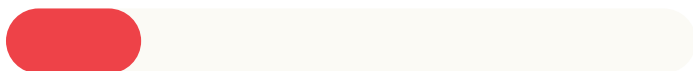
Slightly concerned (33%)



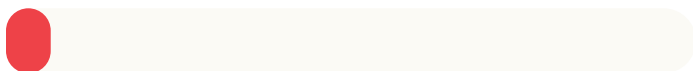
Moderately concerned (32%)

In addition to daily budget impacts and productivity losses, compliance inefficiencies can lead to significant repercussions, including financial losses from incomplete or lost records during accidents or legal disputes. Inaccuracies may be exploited, raising the risk of severe penalties.

A notable concern for fleet operators and independent truckers, 90% are worried about nuclear verdicts, with 25% extremely worried. Midsize fleet leaders (35%) are particularly anxious about this, likely due to resource challenges affecting compliance.

Inefficient record keeping impedes growth and even risks business solvency. Manual record management processes also put fleets and independent truckers at risk of a catastrophic nuclear verdict. Business owners and operators are unlikely to achieve peace of mind until they adopt more streamlined solutions.

Fleet operators and independent truckers are drowning in paperwork

Manual compliance management processes stall productivity and drain resources. However, fleets still struggle to break free of legacy workflows, hindering their ability to maximize business growth and income.

More than half of fleet operators (55%) named complex compliance documentation and paperwork requirements as a top barrier to getting drivers seated. Background check and driver verification delays are also a top hurdle for 54% of fleets. These delays can ripple through operations, resulting in missed opportunities and increased costs.

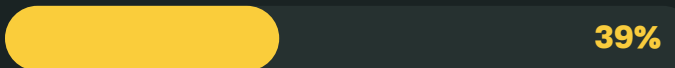

Top challenges fleet operators and independent truckers face when managing toll payments



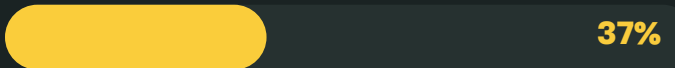

Inability to predict what toll expenses will be at the end of each month



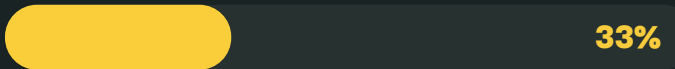

Complexity in managing multiple transponders and toll accounts



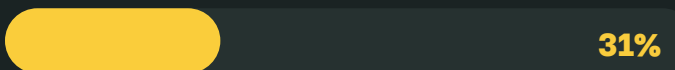

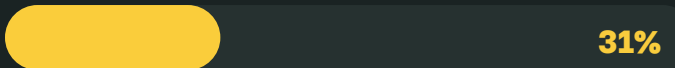

METHODOLOGY

In July and August 2024, Fleetworthy surveyed 300 U.S.-based professionals in the trucking industry. The respondent pool included full-time employees of logistics companies and private fleets, as well as independent trucker owner-operators. Respondents working for logistics companies or fleets were all involved in the decision-making process for commercial fleet activities at the director level or above.
